# Brief on the C20 Face-to-Face Meetings

---

The Face-to-Face meetings are held every year to facilitate an open dialogue between Civil Society Organizations and G20 officials, to exchange thoughts and co-create solutions. The discussions also aid in finalizing the C20 policy briefs and recommendations to G20 leaders.

The C20 exists to advocate for the ideas and interests of global citizens and communities in shaping G20 policies which can be implemented to deliver positive impact of all.

Currently, the C20 is composed on more than 500 Civil Society Organizations from G20 countries and beyond. Many of our members are topic experts, and are able to provide technical input on G20 issues.

The C20 is structured to mirror working groups in G20 Sherpa and Finance Tracks, including 11 working groups: [Anti-Corruption](#), [Climate](#), [Energy & Sustainability](#), [Digital Economy](#), [Education](#), [Employment & Social Protection](#), [Gender](#), [Global Health](#), [Infrastructure](#), [International Financial Architecture](#), [Local2Global](#), [Trade & Investment](#).

Blair Glencorse is the International Lead for the C20 Anti-Corruption Working Group. Blair is leading a movement for accountability and integrity around the world through the [Accountability Lab](#). The Lab works to build accountability—using the arts, media, culture and technology. Blair and his team have done everything from helping to found the first film school in Liberia to monitoring and improving public services in Pakistan to running a global TV show called Integrity Icon to “name and fame” honest government officials. The Accountability Lab recently won the UN’s International Anti-Corruption Excellence Award.

Petter Matthews is an infrastructure and international development specialist with more than 40 years’ experience. He is also the Executive Director of Engineers Against Poverty (EAP), an independent NGO that works to influence infrastructure policy and engineering practice to maximize the benefits of infrastructure investment for poor and marginalized people. He has a BA Development Studies and Politics (SOAS, London) and an MSc in Social Policy and Planning in Developing Countries (LSE, London).

Christina Catalano is Forbes Under 30 startup CEO and a noted civil rights activist. She is the Founder and CEO of Thrive Innovation, an education startup that creates innovative solutions and teaching services for clients. Catalano is also the Founder and Chairman of The RISE Anti-Bullying Initiative, which has grown to become one of the largest and amongst the most recognized anti-bullying initiatives in the world. The Director-General of the Ministry of Ethiopia calls Catalano "a global figure." The Minister of Liberia calls Catalano "one of the most important activists of our time." Catalano has fought for not only anti-bullying policy, but for women's rights, workplace rights, children's rights, democracy, and peace between international states - and won.

**Dr. Mohammad Nurunnabi, *PhD*** is the Aide to the Rector on Research and Internationalization, Chair of the Department of Accounting, and an Associate Professor in Accounting at Prince Sultan University, Saudi Arabia. He is an Academic Visitor (Senior Member) of St Antony's College, University of Oxford, Oxford, United Kingdom. He holds a PhD with outright pass (no corrections) from the University of Edinburgh, UK. He is a senior fellow of Higher Education Academy (SFHEA), UK, a Chartered Management Accountant (CMA), an academic fellow of the Association of International Accountants (FAIA-Acad), and fellow of the Royal Society of Arts (FRSA). His most recent book is *The Role of the State and Accounting Transparency* (Routledge: London and New York; 2016).


# Virtual meeting guide: During the call

## A quick reminder to:


- 🔊 Raise your voice when speak.
